Welcome and Moment of Silence	The Support Team began the meeting at 6:04pm by welcoming all attendees. They then led the committee in a moment of silence to honor those lost to HIV and those still fighting the virus. Stephanie Berroa-Allen then led an icebreaker and asked attendees to share their favorite drink.
Approval of the Agenda & Minutes	Stephanie Berroa-Allen reviewed the meeting's Agenda. Saquan Stevenson motioned to approve the Agenda, seconded by Jocelyn Perry. A virtual poll was conducted and the Agenda was approved. The Support Team presented the Meeting Minutes from the February Committee Meeting. Stephanie Berroa-Allen motioned to approve the Meeting Minutes, seconded by Kelly Williams. A virtual poll was conducted and the Meeting Minutes were approved.
Meeting Evaluation	The Support Team reviewed the February Meeting Evaluation with attendees. 	Following the Evaluation Review the Support Team led the Committee in a moment of silence to honor Hydeia Broadbent.	
Old Business	Stephanie Berroa-Allen transitioned the Committee to Old Business with an update on Community Engagement's Cycle 1 Recommendations.	
	The Support Team shared the finalized recommendations in the chat and stated they would also send them in the follow-up email. They also informed the Committee that the recommendations will now move through the Monitor and Evaluation Guidance that the Integrated Planning Committee has developed.	
New Business	For New Business Stephanie Berroa-Allen presented an Education Didactic for Program 1.2- Expand community engagement in health communication initiative and research.	
	This Education Didactic started with an update from the NJDOH which was MVOS (My Voice Our Story). Following this, there was a definition of health communication. Stephanie Berroa-Allen then presented some things happening in NJ including Health Education Programs, Community Based Organizations, Community Health Workers, and Harm Reduction Sites. She also presented a list of successes including, Psychosocial Support Groups, Pharmaceutical Collaborations and Support Groups, Gilead, Merck, ViiV, and Staffing more CHWs.	
	The Support Team then shared the Miro Board for collaboration on Program Activity 1.2.	
	Michael Hager shared some information in the chat about the Dear Rosa Project and a program in Dallas that involves outreach staff providing services in jails.	
	The Support Team suggested thinking about funding	







educational programs for students that focus on risk reduction.

Crystal Mitchell added Iris House used to go into a local school to provide lessons about HIV, STDs, etc as part of their curriculum. Funding was cut after a few years, but they still house the curriculum. She said that if more schools were able to do this and establish relationships with local agencies, this could help educate the community and get them involved.

Stephanie Berroa-Allen suggested that if it is hard to get into the schools with these educational programs, then they could consider working with Family Success Centers.

Stephanie Berroa-Allen and Abraham Corsino both mentioned that it is often difficult to provide education in schools because of how HIV is stigmatized.

The Support Team followed up by suggesting thinking about how to do this in non-traditional ways.

Gabrielle Ferrigno suggested that within the RFAs, they ask for the agencies to create educational programs and rebuild their relationships with the schools again.

Jose Avila also suggested creating their programs for college students.

Shalik Thompson stated that one deliverable could be to create a process to ensure that agencies who are receiving funding are held accountable.

The Committee then brainstormed the following stakeholders:

 DOH, Board of Education, PTA, Local Businesses/Organizations, Commissioner of Education, Policy Makers, Faith Based Organizations, CBOs, and Community Members

Stephanie Berroa-Allen then asked if there would be a way to incentivize community members to get involved because often, they do not see any funding or incentives.







	Jose Avila reminded the Committee that HIV affects everyone, not just a certain socioeconomic status. He suggested that this is kept in mind when thinking about incentives.
	The Support Team suggested thinking outside of the box about things such as free gym memberships or partnering with colleges.
Attendee Announcements	Stephanie Berroa-Allen next transitioned the Committee to share any announcements.
	She started by announcing that Camden AHEC is going to be in Trenton working with someone at Quaker House from 10am – 4pm providing services to the first 40 individuals who come out.
	Shalik Thompson shared the location of his agency (49 Mount Pleasant Ave East Orange, NJ) that provides services to uninsured and underinsured individuals.
	Jose Avila shared a flyer for a Transgender Day of Beauty and Wellness that will take place on March 26 th at EDGE.
	Crystal Mitchell announced that Iris House was featured in this year's Windows of Understanding Project. This is a nonprofit organization that partners with local organizations who will allow an artist to paint the mission of their organization on windows to help bring in individuals.
